TERMS OF USE

Please read these Terms of Use carefully before using this site. Your use of the Website will be considered as acceptance of the Terms of Use.

Any use of Website provided by Sylvania and or its subsidiaries is subject to these Terms of Use. The Terms of Use may be amended, modified, or replaced by other terms and conditions from time to time without further notice. Your continued use of the Website after any of these Terms of Use have been changed will be deemed as acceptance of the updated Terms of Use. 1. Services
